This dog will be sold with the full guarantees below unless other arrangements are made in writing.

Guarantees:

If purchasing a puppy, adult height or dentition is not guaranteed. If purchasing an adult dog, height and dentition will be disclosed before purchase. Two descended testicles are guaranteed in male puppies or dogs.

This puppy or dog comes with current shots, including but not limited to regular DA2PPv, Rabies (if older than 26 weeks) and Novibac Intra-Trac 3 for kennel cough. They have received regular wormings with Panacur or Pyrantel, and any additional treatments to ensure of good health.

This dog is guaranteed until 3 years of age to be clear of genetic health defects including: hip dysplasia, genetic diseases of the eye that render the dog unable to CERF, and vWD disease (by pedigree); provided that such defect was not caused by neglect, mistreatment or injury. The sire and dam have a normal thyroid. The puppy has not been tested. Sellers further guarantee that sire and dam have OFA and CERF ratings of good or better for hips and eyes, respectively. This guarantee is extended only to the original buyer and is void if this dog has been used for breeding. Sellers reserve the right to have his/her own veterinarian retest the dog at his/her expense. If a problem is found with the above dog, Sellers have the choice of requiring the return of the dog and all AKC paperwork, or allowing Buyer to retain the dog (spay/neutering required). Sellers are not responsible for shipping, travel expenses, or any other costs incurred by Buyer in return of above dog.

This dog is guaranteed to be healthy for a period of 72 hours from the time of acquisition and will be seen by our veterinarian 24 hours before leaving, 48 hours if acquisition occurs on a Monday or the day after a holiday. In the event that the puppy is acquired on a weekend or holiday, the guarantee begins on the next working day. Full purchase price will be refunded if above dog is found to be ill, provided that the dog was examined by a licensed veterinarian during the first 72 hours, and the dog is returned to Sellers with original paperwork, including AKC papers. Proof of any claim must be provided to Sellers Within this time and arrangements for the dog's return must be made immediately and not to exceed a week from purchase. If Buyer wishes to keep the dog, all necessary medical care to bring it to good health will be provided by Sellers.

Terms of sale:

If this dog does not mature to be of show quality by 36 months of age, Sellers will sign off co-ownership when the dog is neutered. If the dog does mature to be of show quality by 36 months of age, Sellers will sign off on co-ownership when the dog has attained an AKC championship title.

- Buyer agrees to show and make all attempts to finish this dog's AKC Championship.
- The dog may not be resold or transferred to another home without the expressed consent of Seller. She is to be returned to Sellers (Cathy and Doug Ohlendorf) if she needs to be rehomed.
- This dog may not be spayed/neutered unless all terms of this contract are met, unless the health of the dog is compromised, in which case Sellers must be contacted prior to any action.
- If the dog is spayed/neutered or sold without prior consent from Sellers, Buyer will incur a \$2000 penalty fee.
- If this dog has not been individually registered, Buyer will register it through AKC with the KeDiOs prefix on its registered name. If the dog is not registered with the KeDiOs prefix, Buyer will incur a \$1000 penalty fee. Buyer is responsible for all the registration costs.
- Buyer is additionally responsible to register, at his/her expense, dog with AKC CAR by 1 month following acquisition and prior to showing dog at any conformation, agility, obedience, or herding event. Sellers will arrange chip placement. Failure to register as just stated will result in a \$1000 penalty fee.
- If dog is male, Sellers retain right to use dog as stud for bitches owned by Sellers.
- If dog is bitch, Sellers will receive pick puppy from the bitch's second litter. Sellers will choose their pick puppies by the age of 10 weeks. Buyer is responsible for shipping charges for shipping the puppies to the Sellers, unless other arrangements are made. Buyer has the responsibility to provide pictures and measurements. Puppies are to be in good health and condition at the time of Sellers' receipt. Any expenses incurred by Sellers to take care of and treat sick puppies will be the responsibility of Buyer. Sellers will choose the sire for this litter with agreement from Buyer. If Sellers are not notified of bitches heat in time to choose a stud, or if bitch is bred to a dog without prior consent from Sellers, Sellers will have the option to choose a puppy from that litter as a penalty and still be entitled to the original puppy or puppies back out of bitch's next breeding, or to be entitled to an \$800 penalty fee in lieu of the puppy, at Sellers' discretion. All breeding expenses and care of the litter will be the responsibility of Buyer. Sellers will be able to name her puppy/puppies back and place the KeDiOs prefix on its/their names.

Special Conditions:

Neither this dog, nor puppies sired by this dog, may be sold to/through any wholesale outlets, pet stores, puppy mills or commercial enterprise of any type or relinquished to any humane society, animal control agency or rescue organization. In addition no puppy produced by this animal will be sold for the purpose of vivisection or donated to any charitable organization to be sold or auctioned. If it is found that any of these activities has taken place there will be a \$2000 penalty per dog sold, which will be donated to benefit ASSA Sheltie Rescue, and Sellers will have the right to repossess the dog and any offspring produced by same. If above dog is an abused or neglected, Sellers reserve the right to take immediate possession of the dog. If Buyer can no longer keep the dog, the Buyer agrees to return the dog to the Sellers. Upon receipt of the dog, the Sellers will endeavor to find a new home for the dog. Any monies recovered for the dog by the Sellers will be returned to the Buyer, less any expenses incurred by the Sellers in recovery and re-placement of the dog.

Both the Buyer and Sellers have read the above contract and understand and agree to all the conditions stated herein. No amendments or attachments have been made/added to this contract. This contract is legal and binding. Both parties agree that any legal action to enforce this contract will be brought forth in Wright County MN where breeder resides.
